TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment"), dated as of March 30, 2007 is made by and among LEGGETT & PLATT, INCORPORATED, a Missouri corporation with its principal place of business situated in the State of Missouri ("L&P") and L&P PROPERTY MANAGEMENT COMPANY, a company related to Buyer and a Delaware corporation with its principal place of business situated in the State of California ("LPPMC") (L&P and LPPMC collectively referred to as "Seller") and SLEEP INNOVATIONS, INC., a New Jersey corporation ("Buyer").

RECITALS

WHEREAS, pursuant to a certain Asset Purchase Agreement ("APA") executed on or about the March 12, 2007, Buyer is purchasing from Seller certain assets and properties, including L&P's prime foam businesses and operations and certain trademarks and company names that are either used by L&P in the operation of its prime foam businesses and operations or that L&P has a bona fide intent to use in such business and operations; and

WHEREAS, Seller and Buyer desire to formalize their agreement as to the assignment of such trademarks and company names, including the right, title and interest in, to and under such trademarks and company names in conjunction with the sale pursuant to the APA of the portion of the business in connection with which Seller has a bona fide intent to use any of such trademarks filed as intent to use applications, together with the goodwill of the business symbolized by the same; and,

NOW, THEREFORE, in consideration of the premises and other good and valuable consideration, the parties intending to be legally bound agree as follows:

- 1. <u>Trademark Assignment:</u> Seller does hereby sell, assign and transfer unto Buyer, its successors, assigns and legal representatives, the entire right, title and interest in the trademarks set forth in the attached Exhibit A, including such trademarks whose registration is pending and which were filed as intent-to-use applications (the latter, the "ITU Trademarks" and all of the foregoing, collectively, the "Trademarks"), the goodwill of the business symbolized by the Trademarks, the registrations and application(s) for registration thereof in all countries, all renewals, extensions, and foreign counterparts thereof, and all common law rights, together with the right to sue and recover damages for future or past infringements of any of the foregoing. This sale, assignment and transfer includes the rights of priority under the International Convention for the Protection of Industrial Property, Inter-American Convention Relating to Patents, Designs and Industrial Models, and any other international agreements to which the United States of America adheres.
- 2. <u>Company Name Assignment:</u> Seller does hereby sell, assign and transfer unto L&P, its successors, assigns and legal representatives, the right, title and interest in the Company Names and domain names set forth in the attached Exhibit B, the goodwill of the business symbolized by the names, the registrations and application(s) for registration thereof, and all common law rights. This sale, assignment and transfer further includes the right of priority under the International Convention for the Protection of Industrial Property, Inter-American Convention

Relating to Patents, Designs and Industrial Models, and any other international agreements to which the United States of America adheres.

- 3. <u>Cessation of Use of the Trademarks and Company Names:</u> Upon execution of this Assignment, Seller agrees to cease from all further use of the Trademarks and Company Names, the rights to which are sold, assigned and transferred pursuant to this Assignment, and agrees to not use any mark or domain name which is confusingly similar to such Trademarks and Company Names.
- 4. <u>Additional Documents</u>: Seller shall, without additional consideration, execute and deliver any further documents or instruments, and take such other actions, requested by Buyer to document, record or perfect the Buyer's rights granted herein, such as formal assignments of trademark suitable for recording in the applicable United States or other foreign national trademark offices.
- 5. This Assignment shall not expand, limit or modify the rights and obligations of the parties under the APA. To the extent that there is any inconsistency between the provisions of the APA and the provisions of this Assignment, the provisions of the APA shall control.
