TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT is made as of January 8 2007, between **HIRE DYNAMICS, LLC**, a Georgia limited liability company located at 3479 Lawrenceville Suwannee Road, Suite A, Suwannee, Georgia 30024 ("Hire Dynamics") and **H.I.R.E. DYNAMICS INT'L, LTD**, a Minnesota corporation located at 2489 Rice Street, Suite 190, Roseville, Minnesota 55113 ("Company").

RECITALS

- A. Hire Dynamics and Company have entered into a Trademark and Settlement Agreement dated January 8, 2007 (the "Settlement Agreement"), in which Company agrees to assign to Hire Dynamics the federal registration for the mark H.I.R.E. DYNAMICS, Reg. No. 2732258 (the "Mark").
- B. The parties are executing this short-form trademark assignment agreement for recordation with the United States Patent and Trademark Office.


AGREEMENT

In consideration of the above recitals and the promises set forth below, the parties agree as follows:

Company transfers and assigns to Hire Dynamics the Company's right, title and interest in and to the Mark, together with the associated good will and related rights as further described in the Settlement Agreement, all registrations and applications for registration of the Mark in the United States and any foreign countries, including any renewals and extensions of any registration that is or may be secured. The provisions of this Agreement will benefit Hire Dynamics, its successors, assigns and other legal representatives, and are binding upon Company, its respective successors, assigns and other legal representatives.
