**RELEASE OF SECURITY INTEREST IN
TRADEMARK COLLATERAL**

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL, dated as of April 9, 2007 (this "Release"), is made by Ableco Finance LLC ("Ableco") in favor of Sleep Innovations, Inc., Comfort Co., Inc., Advanced Innovations East, L.L.C., Advanced Innovations Central, L.L.C., and Advanced Innovations West, L.L.C. (collectively, "Grantors"), as follows:

W I T N E S S E T H

WHEREAS, pursuant to that certain Security Agreement dated as of August 15, 2005, made by the Grantors in favor of the Agent ("Security Agreement"), the Grantors granted Ableco a security interest ("Security Interest") in and to all of Grantors' right, title and interest in and to certain collateral, including the Trademark Collateral (as defined in the Grant of Security Interest);

WHEREAS, pursuant to that certain Trademark Security Agreement, dated August 15, 2005 (the "Grant of Security Interest"), by and between Ableco and Grantors, and recorded with the United States Patent and Trademark Office on August 24, 2005 at Reel/Frame No. 3146/0032, Grantors, by reference to the Security Agreement, reaffirmed their intent to grant a Security Interest in and to the Trademark Collateral (as defined in the Grant of Security Interest);

WHEREAS, Grantors have satisfied all of their obligations as set forth in the Security Agreement; and

WHEREAS, Grantors have requested that Ableco release its Security Interest in and to the Trademark Collateral granted by the Grant of Security Interest and to terminate the Grant of Security Interest.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Ableco hereby TERMINATES, CANCELS and RELEASES the Security Interest it has in the Trademark Collateral, including, but not limited to, each of the trademark registrations and applications set forth in Schedule A, attached hereto and incorporated herein by reference, together with the goodwill of the business symbolized by said trademark registrations and applications.

Ableco hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonable necessary to effect the release of the Security Interest contemplated hereby.

For the avoidance of doubt, nothing in this Release shall be deemed a representation and warranty with respect to the Trademark Collateral, or Grantors' or Ableco's right, title or interest therein or thereto.
