REQUEST FOR AMENDMENT

WHEREAS on February 26, 1988 Woodstream Corporation and Cascade International Industries, Inc. entered into a Trademark License and Escrow Agreement (the "Agreement") in connection with the use of certain marks relating to fishing products, including those United States trademark registrations set forth on Schedule A attached hereto (collectively, the "Trademarks").

WHEREAS, the Agreement was further amended on July 15, 1988 and recorded with the United States Patent and Trademark Office (the "PTO") on August 9, 1988 at reel/frame 0615/0329;


WHEREAS, on July 20, 1988, Berkley Inc. purchased the stock of Cascade International Holdings, Inc. (the parent of Cascade International Industries, Inc.) and Cascade International Industries was then dissolved on March 23, 2000;

WHEREAS, on August 16, 1989, Woodstream Corporation assigned the marks previously licensed to Cascade International Industries, Inc. to Berkley Inc.;

WHEREAS, on June 30, 2000 Berkley Inc. changed its name to Pure Fishing Inc.;

NOW THEREFORE, Pure Fishing, Inc. requests that the Commissioner update the records of the PTO to reflect that the aforementioned license agreement is no longer an encumbrance on the Trademarks as the Trademarks are now under common ownership.
