

RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS is given as of this 16th day of April, 2007, by COMPASS BANK, N.A. ("Assignor"), in its capacity as Assignor in favor of HARTLEY FOOD PRODUCTS, LP, a Texas limited partnership, ("Assignee").

WHEREAS, Assignee granted Assignor a security interest in certain collateral pursuant to a Loan and Security Agreement, dated as of July 7, 2006, by and between Assignee, Assignor, and a Trademark Pledge Agreement, dated as of July 7, 2006, by and between Assignee and Assignor, which was recorded with the U.S. Patent and Trademark Office on October 6, 2006, at Reel 3403 / Frame 0055 (hereinafter, collectively the "Security Agreement");

- (b) Licenses, as defined in the Security Agreement, including those listed on Exhibit "B" hereto;
- (c) Proprietary Rights, as defined in the Security Agreement; and
- (d) the goodwill of the Assignee's business connected with and symbolized by the Trademarks, Licenses, and Proprietary Rights (collectively, the "Collateral");

WHEREAS, Assignor desires to release its security interest in the Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby releases its security interest and lien in the Collateral and reassigns any and all interest that it may have therein to Assignee.

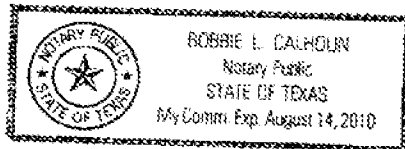
