DECLARATION OF JAN R.WEINBERG

TRADEMARK: COLLEGETOWN

REGISTRATION NUMBER: 2011820

This declaration is filed pursuant to §503.06(c) of the Trademark Manual of Examining Procedure, for the purpose of correcting a series of assignments and a security interest improperly filed and recorded by third parties against the proper owner of the captioned trademark registration.

Jan R. Weinberg, having been duly warned that willful false statements and the like so made are punishable by fine or imprisonment or both under §1001 of Title 18 of the United States Code and that such willful false statements may jeopardize the validity of this document or the captioned trademark registration, hereby declares that he is the President of Collegetown Relocation, LLC and authorized to execute this document, that the facts stated in this document are true; that all statements made of his own knowledge are true and that all statements made on information and belief are believed to be true.

Collegetown Relocation LLC is the owner of the captioned trademark registration. The original application for this mark was filed on September 27, 1995 by Rezun Interactive Concepts, Inc. The trademark mark was registered October 29, 1996. On April 10, 2000 Rezun Interactive Concepts, Inc. assigned the entire interest of the captioned trademark registration to Jan R. Weinberg Management Corporation. This assignment was recorded on April 21, 2000 at Reel 2070/ Frame 0004.

On April 14, 2000 Jan R. Weinberg Management Corporation assigned the entire interest of the captioned trademark registration to Collegetown Relocation, LLC. This assignment was recorded on April 21, 2000 at Reel 2302/ Frame 0280.

Subsequent to this last, correct assignment, Icollege, Inc., a company with no interest whatsoever in the captioned trademark registration, improperly filed and recorded an assignment of the captioned trademark registration to Blackboard Icollege, Inc. This assignment was executed on December 15, 2000 and recorded on October 2, 2001 at Reel 2381/ Frame 0098.

On May 3, 2005, Blackboard Icollege, Inc. executed an assignment purporting to assign the entire interest of the captioned trademark registration to Blackboard Inc. This assignment is recorded at Reel 3265/ Frame 0140.


On February 28, 2006 Blackboard Inc. purported to convey a security interest in the captioned trademark registration to Credit Suisse, Cayman Islands Branch, AS. The security interest was recorded on March 10, 2006 at Reel 3265 Frame 0140.

The assignments from Icollege, Inc. to Blackboard Icollege, Inc. and from Blackboard Icollege, Inc. to Blackboard Inc., as well as the security interest granted to Credit Suisse, Cayman Islands Branch, AS, were all erroneously filed and recorded.

Collegetown Relocation, LLC has contacted Blackboard Inc. and requested Blackboard Inc. to file corrected documents. Blackboard Inc. is unwilling to file corrected documents, and Collegetown Relocation, LLC is filing this declaration to correct the error, as permitted by §503.06(c) of the Trademark Manual of Examining Procedure.

The chain of title for the captioned trademark registration should not be considered altered by the erroneous assignments and security interest. The last correct assignee Collegetown Relocation, LLC, has been and continues to be the owner of the captioned trademark registration.
