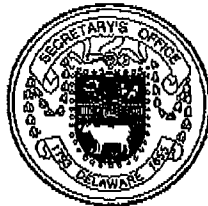

This Amendment to the Amended and Restated Certificate of Formation of ZLB Behring L.L.C., dated November 27, 2006, has been duly executed and is being filed by the undersigned, as an authorized person, in accordance with the provisions of 6 Del. C. § 18-208, to amend and restate the original Certificate of Formation of ZLB Behring L.L.C. (whose original name was "Verion L.L.C."), which was filed with the Secretary of State of the State of Delaware (the "Secretary of State") on May 15, 1995, as amended by the Certificate of Amendment, which was filed with the Secretary of State on July 13, 1995, as amended and restated by the Amended and Restated Certificate of Formation of Centeon L.L.C., which was filed with the Secretary of State on December 22, 1999 (as amended and restated, the "Certificate"), as amended and restated by the Amended and Restated Certificate of Formation which was filed with the Secretary of State on June 28, 2004, to form a limited liability company under the Delaware Limited Liability Company Act (6 Del. C. § 18-101, et seq.).

The Certificate is hereby amended and restated in its entirety to read as follows:

- 1. **Name.** The name of the limited liability company is "CSL Behring L.L.C." (the Company).
