ARTICLES OF SECOND AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF
WEBFIRE.COM, INC.

KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned, as President and Secretary of WEBFIRE.COM, INC., a corporation duly organized and existing under the laws of the State of Alabama (the "Corporation"), hereby certify that, in accordance with Section 10-2B-10.01, 10-2B-10.03 and 10-2B-10.07 of the Alabama Business Corporation Act (the "ABCA"), the Articles of Incorporation of the Corporation were amended and restated by unanimous written consent on the 3rd day of July, 2003, and state as follows:

FIRST: That the present name of the Corporation is WEBFIRE.COM, INC.;

SECOND: That the date of the filing of the original Articles with the Judge of Probate of Madison County, Alabama, was November 10, 1999;

THIRD: That the Articles of Incorporation of the Corporation were amended by Articles of Amendment on August 7, 2001;


FOURTH: The Articles of Incorporation shall be further amended by Articles of Second Amendment which were adopted by the shareholders of the Corporation on the date hereof, in the manner prescribed by the Alabama Business Corporation Act:


RESOLVED, that ARTICLE FIRST of the Articles of Incorporation of WEBFIRE.COM, INC. be, and the same hereby is, amended by changing the name of the corporation from WEBFIRE.COM, INC., to MEMBERCLICKS, INC.

FIFTH: The number of shares voted for such amendment was Thirteen Thousand Nine Hundred Sixty (13,960) shares of \$0.10 per share par value voting common stock; the number of shares voted against such amendment was zero (0); and the number of shares that abstained from voting was zero (0).


