NOTICE OF SECURITY INTEREST
U.S. TRADEMARKS

WHEREAS, Tecnocap LLC, f/k/a Penn Wheeling Acquisition Company, LLC, a Delaware limited liability company (the "Grantor"), owns the trademarks listed on the annexed Schedule A, which trademarks are registered, to the extent indicated, in the United States Trademark Office (the "Trademarks");

WHEREAS, pursuant to that certain Loan Agreement, dated March 27, 2006, by and among the Grantor, Tecnocap Acquisition Company, a Delaware corporation ("Tecnocap") and National City Bank, a national banking association (the "Grantee"), (as amended, modified or supplemented from time to time, the "Loan Agreement"), the Grantor and Tecnocap are obligated to the Grantee, and the Grantor has entered into that certain Patent, Trademark and Copyright Security Agreement, dated March 27, 2006 (the "Security Agreement") in favor of the Grantee; and

WHEREAS, pursuant to the Security Agreement, the Grantor has granted to the Grantee, a security interest in all right, title and interest of the Grantor in and to the Trademarks, the registrations or applications for registration thereof, and all proceeds thereof, including, without limitation, any royalties, claims for infringement and proceeds of sale or other disposition thereof (the "Trademark Collateral") to secure the payment and performance of the Debt (as defined in the Loan Agreement).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, the Grantor, pursuant to the Security Agreement, did and does hereby grant to the Grantee a mortgage on, pledge of and security interest in the Trademark Collateral to secure prompt payment and performance of the Debt.



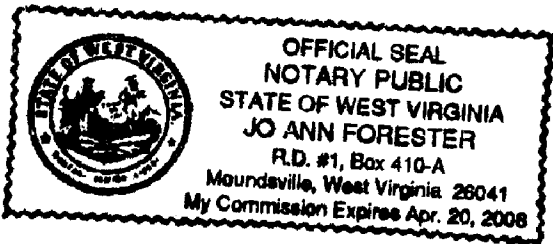
