NOW, THEREFORE, in consideration of the foregoing and the mutual promises, covenants and conditions contained herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby assign, transfer, convey and set over unto Assignee its full right, title and interest, including common law rights, to and under the Assigned Marks, together with the goodwill of the business symbolized by said Assigned Marks, U.S. applications and the forthcoming registrations therefor, U.S. and Canadian registrations and any renewal rights therein, and the exclusive right to enforce the Assigned Marks in the United States, Canada, and anywhere else in the world in the sole name of Assignee, its successors and assigns; the aforesaid transferred rights, title and interests to be held and enjoyed by Assignee, its successors, legal representatives and assigns as fully and entirely as the same would have been held and enjoyed by Assignor had this assignment not been made.
