**TRADEMARK ASSIGNMENT AGREEMENT**

**THIS AGREEMENT** effective as of July 9, 2001 and dated as of the 15<sup>th</sup> day of August, 2001:

**BY AND BETWEEN**

- (1) **COREL CORPORATION**, a corporation amalgamated under the laws of Canada (the "Assignee"); **AND**
- (2) **COREL CORPORATION LIMITED**, a wholly owned subsidiary of the Assignee, incorporated under the laws of Ireland (the "Assignor").

**RECITALS:**

- A. The Assignor (a) is the registered proprietor of certain trade marks, and (b) is the applicant in respect of certain trade mark applications and (c) is the legal and beneficial owner of certain other marks.
- B. By virtue of the Asset Transfer Agreement (as hereinafter defined) the Assignor has agreed to assign to the Assignee all the rights in the said trade marks and trade mark applications and to certain unregistered marks used by the Assignor, together with all goodwill connected thereto, on the terms set out in this Assignment.

**IT IS HEREBY AGREED** as follows:-

1. In this Assignment, the following terms shall have the following meanings:

- "Asset Transfer Agreement" shall mean the agreement executed between the Assignor and the Assignee on the same date as this Assignment Agreement pursuant to which it was agreed that the Assignor would make a distribution of its trade and assets to the Assignee, including but not limited to, the Trade Marks and Unregistered Trade Marks;
- "Effective Date" shall effective as of July 9, 2001;
- "Trade Marks" shall mean such of the trade marks and trade mark applications, brief particulars of which are set out in the First Schedule hereto, of which the Assignor is the current registered proprietor;
- "Unregistered Marks" shall mean the marks listed in the Second Schedule hereto.

2. In consideration of the Assignee taking on the rights and obligations in the Asset Transfer Agreement (receipt of which is hereby acknowledged) the Assignor **HEREBY ASSIGNS** with effect from the Effective Date, free from all liens, charges and encumbrances, to the Assignee, all rights, title and interest in and to the Trade Marks and the Unregistered Marks including the benefit of any use of the Trade Marks and the Unregistered Marks (including, without limitation, the benefit of any use of the Trade Marks prior to their registration) and all statutory and common law rights connected with the said Trade Marks and Unregistered Marks and together with all other rights and goodwill therein wherever in the world, and together with all the rights of action, powers and benefits belonging to the same, including the right to sue for and obtain damages and other relief in respect of any infringement and/or any violation of any common law rights (whether past, present or future) of the Trade Marks and the Unregistered Marks or any of them **TO HOLD** the same unto the Assignee absolutely.

3. The Assignor hereby covenants that it shall not use the Unregistered Mark itself after the date

of this Agreement, save in accordance with the terms of a separate trademark licence agreement, if any between the parties.

4. The Assignor covenants with the Assignee that, it will, execute all such further assignments, transfers, deeds, documents or other assurances and do all further acts and things as the Assignee may require at any time in the future in order to enable the Assignee to become registered as the proprietor of the Trade Marks and otherwise to secure the benefit of the rights hereby assigned and/or to maintain and protect the Trade Marks.

5. In the event that the validity of the Trade Marks or any of them, is challenged, or the registration thereof is opposed (whether prior to or after the Trade Marks or any of them have been registered) on any point upon which the Assignor has or can procure information or advice which may assist in meeting and/or defeating or reducing the effect of such challenge, the Assignor agrees to supply or procure the supply of such information and/or advice as is reasonably required without unreasonable delay, but subject to the right to charge the Assignee all expenses properly and reasonably incurred and agreed by the Assignee, in pursuance of this provision.

6. This Assignment shall be governed by and construed in accordance with the laws of the Province of Ontario, and each of the parties irrevocably submit for all purposes in connection with this Agreement to the non-exclusive jurisdiction of the Courts of Ontario.

7. IT IS HEREBY CERTIFIED that the consideration (other than rent) for the sale is wholly attributable to property which is not residential property.




