ASSIGNMENT

THIS ASSIGNMENT is entered into as of April 12, 2007 (this "Assignment") by and between Puget Sound Rope Corporation ("Assignor") and Viking Rope Corporation ("Assignee").

Assignor agrees that it shall do, execute, acknowledge and deliver, all acts, agreements, instruments, notices and assurances as may be reasonably requested by Assignee to further effect and evidence the transactions contemplated hereby. This Assignment shall be binding upon and inure to the benefit of the parties hereto and their respective successors and permitted assigns.

Assignor authorizes and requests that the Commissioner for Trademarks record Assignee as the owner of the entire right, title and interest in and to the Trademarks, for the sole use and enjoyment by Assignee, its successors, assigns, or other legal representatives, and hereby covenants that it has the full right to convey the entire interest granted herein, and that it has not executed and will not execute any agreement that conflicts herewith.

IN WITNESS WHEREOF, each of Assignor and Assignee has caused this Assignment to be executed as of the date first written above. This Assignment may be executed in counterparts, each of which shall be deemed an original, but which together shall constitute one and the same instrument.


