ASSIGNMENT OF TRADEMARK SECURITY AGREEMENTS


This Assignment of Trademark Security Agreements (the "Assignment") is dated as of March 8th 2007.

1. This Assignment refers to the Amended and Restated Trademark Security Agreement and Correction of Misidentified Trademark (as amended, modified, restated or supplemented from time to time, the "Security Agreement") dated as of October 4, 2000 between B.A. Ballou & Co. Incorporated (the "Customer"), a Rhode Island corporation, and Bank of America, N.A. ("Bank of America"), successor in interest to BANA Residuals, LLC, which in turn is successor by merger to Fleet Precious Metals Inc. ("FPM"), recorded on June 1, 2001 with the U.S. Patent and Trademark Office ("PTO") at Reel 2309, Frame 0335, as amended by that certain First Amendment to Amended and Restated Trademark Security Agreement recorded on June 27, 2002 with the PTO at Reel 2536, Frame 0770, and as further amended by that certain Second Amendment to Amended and Restated Trademark Security Agreement recorded on March 22, 2005 with the PTO at Reel 3139, Frame 0037, which Security Agreement amends and restates in its entirety that certain Trademark Security Agreement (the "Original Security Agreement") dated as of September 2, 1998 executed by Customer in favor of Fleet Capital Corporation ("FCC") and recorded on March 5, 1999 with the PTO at Reel 1876, Frame 0103, as assigned to FPM by FCC pursuant to that certain Assignment of Trademark Security Agreement recorded on October 19, 2000 with the PTO at Reel 002166, Frame 0966.

2. Bank of America hereby transfers and assigns the Security Agreement and the Original Security Agreement, and all its security interest in the collateral described therein, to **THE BANK OF NOVA SCOTIA**, having an address of One Liberty Plaza, New York, New York 10006, without any representations or warranties, except as expressly provided in that certain Asset Sale Agreement dated October 10, 2006 between Bank of America and The Bank of Nova Scotia.
