Pursuant to the provisions of Section 2.15 of the Texas Revised Limited Partnership Act and Section 17-217 of the Delaware Revised Uniform Limited Partnership Act, Power Well Services, L.P., a Texas limited partnership (the "Converting Entity"), hereby executes the following Articles and Certificate of Conversion:

1. The name of the Converting Entity is Power Well Services, L.P., a Texas limited partnership, which was formed in Texas pursuant to a plan of conversion filed with the Secretary of State of the State of Texas on April 2, 2002. The name of the converted entity shall be Expro Americas, L.P. (the "Converted Entity"). The Converted Entity shall be a Delaware limited partnership.
2. A plan of conversion (the "Plan") for the Converting Entity has been approved by the Converting Entity, as required by the laws of the State of Texas and the governing documents of the Converting Entity.

An executed copy of the Plan will be on file, from and after the conversion, at the principal place of business of the Converting Entity, which will be located at 12777 Jones Road, Suite 280, Houston, Texas 77070.
4. An executed copy of the Plan will be provided, on written request and without cost, to any partner of the Converting Entity or any partner of the Converted Entity, by the Converting Entity, if such request is made prior to the conversion becoming effective, or by the Converted Entity, if such request is made after the conversion becomes effective.
5. The approval of the Plan was duly authorized by all action required under the Texas Revised Limited Partnership Act and the Converting Entity's constituent documents.
