## TRADEMARK ASSIGNMENT

*THIS TRADEMARK ASSIGNMENT* (this "Assignment"), effective as of January 1, 2006 (the "Effective Date") is made from SmithKline Beecham Corporation, a corporation of the Commonwealth of Pennsylvania with principal place of business at Five Moore Drive, Research Triangle Park, North Carolina 27709 ("Assignor"), to Welcome Credit Union, a member-owned non-profit association, pursuant to Charter 455 issued by Credit Union Division of the North Carolina Department of Commerce with a principal place of business at Post Office Box 13398, (MAI-CA428), Research Triangle Park, North Carolina 27709 ("Assignee").

*WHEREAS*, Assignor is the owner of, and desires to assign to Assignee, all right, title and interest in and to: (i) any and all trademark, service mark and intellectual property rights, including rights of priority, and all applications and registrations (US and/or foreign) for the TREE SWIRL design mark including but not limited to their respective United States Trademark Registration No. 2,017,857, hereinafter, collectively, "the Mark"; and (ii) any and all goodwill of the business associated with the Mark; and

*WHEREAS*, Assignee desires to acquire the Mark and any and all goodwill of the business associated therewith from Assignor, subject to the terms and conditions of this Assignment; and

*WHEREAS*, Assignor and Assignee desire to confirm of record the assignment of the Mark and goodwill to Assignee;

*NOW, THEREFORE*, in consideration of the foregoing recitals, the mutual covenants and conditions contained herein, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee hereby agree as follows:

1. Assignor hereby assigns to Assignee all right, title and interest in and to the Mark, together with: (i) the goodwill symbolized by the Mark; (ii) all causes of action, claims and demands and other rights for, or arising from, any infringement or misappropriation, including past infringements and misappropriations, of the Mark; and (iii) any royalties or other consideration owed in connection with use of the Mark after the Effective Date.
2. Assignor further agrees without further consideration to cause to be performed such other lawful acts and to be executed such further assignments and other lawful documents as Assignee may from time to time reasonably request to effect fully this Assignment and to permit Assignee to be duly recorded as the registered owner of the Mark, goodwill and all other rights hereby conveyed.
3. Subject to the terms hereof, Assignee accepts such assignment of the Mark and goodwill.

*IN WITNESS WHEREOF*, the parties have caused this Assignment to be duly executed by their respective authorized officers, all as of the day and year first above written.


