CONTRIBUTION AGREEMENT

THIS CONTRIBUTION AGREEMENT ("Agreement") is made this 27th day of December, 2005, by and between Physicians Practice, Inc., a Maryland corporation (the "Corporation"), and Physicians Practice LLC, a Maryland limited liability company (the "Company").

BACKGROUND

The Corporation has heretofore operated a magazine division (the "Division"). The Corporation desires to contribute all of the operating assets of the Division (the "Assets"), to the Company, in exchange for all of the membership interests of the Company, in accordance with the terms of this Agreement.

NOW, THEREFORE, in consideration of the mutual promises herein contained and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties, intending to be legally bound, agree as follows:

1. CONTRIBUTION OF ASSETS. The Corporation hereby assigns, transfers and sets over unto the Company, all right, title and interest in and to the Assets, and the Company hereby accepts all right, title and interest in and to the Assets.

2. MEMBERSHIP INTERESTS. In exchange and as consideration for the contribution of the Assets to the Company, the Company hereby issues to the Corporation one hundred percent (100%) of the membership interests of the Company.

3. OPERATING AGREEMENT. Upon execution of this Agreement, the Corporation and the Company shall each execute the operating agreement of the Company in the form attached hereto as Exhibit "A" and incorporated herein by reference.
