TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of April 22, 2007, by **AMERICAN CAPITAL FINANCIAL SERVICES, INC.** (“**ACFS**”).

WITNESSETH:

WHEREAS, ACFS and Performance Health, Inc., a Pennsylvania corporation (“**Grantor**”), were parties to that certain Trademark Security Agreement, dated as of May 12, 2006 (the “**Assignment**”), pursuant to which Grantor granted a security interest to ACFS in certain trademarks (the “**Trademarks**”) and Trademark Rights (as defined below) as security for certain obligations owing by Grantor to ACFS, including the Trademarks set forth on Schedule 1 hereto; and

WHEREAS, the Assignment was recorded by the Trademark Division of the United States Patent and Trademark Office on June 12, 2006, at Reel 3325, Frame 0372; and

WHEREAS, Grantor has requested that ACFS release its security interest in the Trademarks and Trademark Rights and reassign the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. ACFS hereby releases its security interest in all of Grantor’s right, title and interest in and to the following (collectively the “**Trademark Rights**”):

(i) each Trademark and application for Trademark listed on Schedule 1 annexed hereto, together with any reissues, continuations or extensions thereof; and


(ii) all products and proceeds of the foregoing, including without limitation, any claim by Grantor against third parties for past, present or future infringement of any Trademark.

2. ACFS hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by ACFS, all of ACFS’ right, title and interest in and to the Trademarks and the Trademark Rights.
