**ASSIGNMENT OF TRADEMARK AND PENDING APPLICATION**



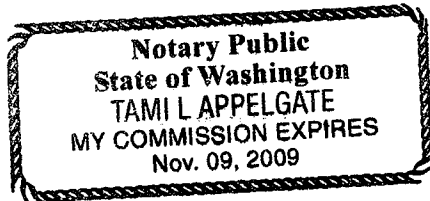
The Commissioner for Trademarks is requested to issue the Certificate of Registration to Assignee.
