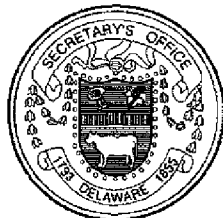

**CERTIFICATE OF AMENDMENT
OF THE CERTIFICATE OF INCORPORATION

1. The name of the corporation is Forum Jobs, Inc.
2. The date of filing of its original Certificate of Incorporation with the Secretary of State of the State of Delaware was December 16, 2003.
