Pursuant to NRS 78.385 and 78.390

1. That the Board of Directors of said corporation at a meeting duly convened and held on the 27th day of December, 2001, passed a resolution, by unanimous written consent, declaring that the following change and amendment in the Articles of Incorporation is advisable:

RESOLVED, that Article FIRST of said Articles of Incorporation be amended to read as follows:

"FIRST. The name of the Corporation is NETg, Inc.

2. That the number of shares of the corporation outstanding and entitled to vote on an amendment to the Articles of Incorporation is one thousand five hundred (1,500); that the said change and amendment has been consented to and authorized by the unanimous written consent of the sole shareholder holding all of the outstanding stocks and entitled to vote hereon.

3. The effective time of the amendment herein certified shall be January 1, 2002.
