## TERMINATION OF SECURITY INTEREST IN TRADEMARKS

**WHEREAS**, the Secured Party has agreed to terminate and release the Security Interest in the Trademarks identified on Schedule A.


**NOW, THEREFORE**, to correct the error, the Secured Party hereby terminates and releases the Security Interest granted to the Secured Party by the Grantor in the following:
