## TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (the "Assignment"), effective as of February 20, 2007 (the "Effective Date"), by and between GRANDY'S, INC., a California corporation, located and doing business at 997 Grandy's Lane, Lewisville, Texas 75067 ("Assignor"), and SSI-GRANDY'S, LLC., a Delaware limited liability company, located and doing business at 140 Heimer Road, San Antonio, Texas 78232 ("Assignee").

WHEREAS, Souper Salad, Inc., a Texas corporation ("Buyer"), and Assignor previously entered into an Amended and Restated Asset Purchase Agreement dated as of February 6, 2007 (the "APA"), pursuant to which Assignor, having been substantively consolidated with Spectrum Restaurant Group, Inc., a Delaware corporation, Spoons Restaurants, Inc., a Texas corporation, Spectrum Foods, Inc., a California corporation, Crabby Bob's Franchise Corp., a California corporation, and Local Favorite, Inc., a California corporation, the reorganized debtors under Case No. SA 03-15911 ES, all of whom are the Debtor and Debtor-In-Possession in that certain Chapter 11 bankruptcy case filed in the United States Bankruptcy Court, Central District of California, Santa Ana Division, as Case No, SA 06-11444 ES, agreed to sell to Buyer or Buyer's designee, pursuant to an order (the "Sale Order") of the court entered in said case, all rights, title and interest of Assignor in and to the trademarks, trade names and common law marks and the corresponding applications and registrations for the Trademarks (the "Trademarks") identified in the attached Schedule A, and the business and goodwill associated with the Trademarks;

WHEREAS, Buyer previously assigned its rights under the APA to Assignee;

WHEREAS, Assignor desires to assign to Assignee, and Assignee desires to acquire, all rights, title and interest of Assignor in and to the Trademarks, the business and goodwill associated with the Trademarks, and the trademark registrations and applications therefor.

NOW, THEREFORE, pursuant to the APA and the Sale Order, in consideration of the covenants set forth in the APA, the sum of \$1.00, and other good and valuable consideration, the sufficiency and receipt of which is hereby acknowledged, Assignor agrees as follows:

1. Assignor does hereby sell, assign, transfer, convey and set over unto Assignee and Assignee's successors and assigns, all of the rights, title and interest of Assignor in and to the Trademarks, together with the goodwill of the business associated with the Trademarks, and the trademark registrations and applications for the Trademarks.

2. Assignor does hereby sell, assign, transfer and set over onto Assignee, its successors, and assigns, all rights, title and interest of Assignor in claims for damages by reason of past infringement of the Trademarks, including the right to sue for and collect same for its own use and enjoyment and for the use and enjoyment of its successors or assigns.

3. Assignor authorizes the Commissioner of Patents and Trademarks of the United States Patent and Trademark Office and any official of any country or countries foreign to the United States whose duty it is to record trademark registrations, applications and title thereto, to record the Trademarks listed on Schedule A, and title thereto, as the property of Assignee, in accordance with the terms of this instrument.

IN WITNESS WHEREOF, the Assignor has caused this Assignment to be executed by its duly authorized officer or representative as of the Effective Date.

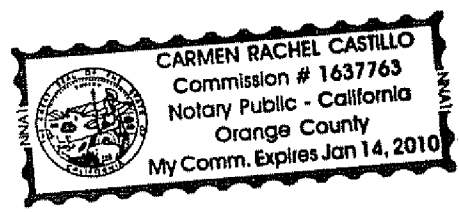
