TRADEMARK ASSIGNMENT

This agreement is entered this 7th of February, 2006 between Handex Group, Inc., f/k/a Handex Environmental, Inc. ("Handex"), SunTrust Banks, Inc. ("SunTrust"), and Handex Consulting and Remediation, LLC ("Assignee").

To that end, for good and valuable consideration, the receipt of which is hereby acknowledged, Handex hereby assigns to Assignee all rights, title and interest in and to the Mark, together with the goodwill of the business in which the Mark is used.
