Huhtamaki Company Manufacturing, a corporation incorporated on the 16th day of May, 1977, pursuant to the provisions of the General Corporation Law of the State of Delaware:

**DOES HEREBY CERTIFY** that this corporation owns all of the outstanding shares of the stock of Huhtamaki Company Technology, a corporation incorporated on the 13th day of November, 1997, pursuant to the provisions of the General Corporation Law of the State of Delaware and that this corporation, by resolution of its Board of Directors, duly adopted by the unanimous written consent of its members, filed with the minutes of the Board dated November 18, 2005, determined to and did merge into itself said Huhtamaki Company Technology, which resolution is in the following words to wit:

**"WHEREAS**, that the Corporation owns 100% of the outstanding shares of Huhtamaki Company Technology, a Delaware corporation ("Subsidiary");

**WHEREAS**, the Board of Directors of the Corporation has determined it to be in the best interests of the Corporation and its stockholder to effect a merger of Subsidiary with and into the Corporation pursuant to Section 253 of the Delaware General Corporation Law, whereby the Corporation shall be the surviving corporation of the merger;

**NOW, THEREFORE, BE IT RESOLVED**, that Subsidiary be merged with and into the Corporation and the Corporation assume all of the rights and obligations of Subsidiary pursuant to Section 253 of the Delaware General Corporation Law;

**FURTHER RESOLVED**, that the merger shall become effective on December 31, 2005;

**FURTHER RESOLVED**, that the officers of the Corporation, or any of them, be, and they hereby are, authorized and directed to take all necessary and appropriate actions to carry out the intent of the foregoing resolutions, including, without limitation, the execution of a Certificate of Ownership and Merger setting forth a copy of the resolutions to merger, and the filing of such Certificate of Ownership and Merger with the Delaware Secretary of State."
