

This assignment agreement is effective as of April 30, 2007.



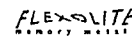
