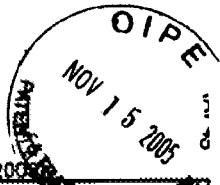

INTELLECTUAL PROPERTY ASSIGNMENT AND LICENSE

This Intellectual Property Assignment and License (the "Agreement") is made and entered into as of the 22nd day of March, 2004 (the "Effective Date"), by and between The David and Lucile Packard Foundation, a California nonprofit public benefit corporation, with a place of business at 300 Second Street, Suite 200, Los Altos, California 94002 ("Assignor") and Princeton University, a not-for-profit corporation under the laws of New Jersey, with a place of business at One Nassau Hall, Princeton, New Jersey 08544 ("Assignee").

WHEREAS, Assignor is the publisher and owner of a bi-annual journal entitled *The Future of Children*, which pertains to the well-being of children; and

WHEREAS, Assignor created or has acquired through assignment sole ownership to the underlying copyrights in the fourteen volumes of *The Future of Children* journal which constitutes 30 issues, including the works set forth in the attached Schedule A, and a website associated with *The Future of Children* journal and any associated source or object code (collectively, the "Works") and owns all right, title, and interest in and to the Works; and

WHEREAS, Assignor has adopted, used and is using marks officially registered in the United States Patent and Trademark Office listed on Schedule A hereto and owns all right, title and interest to the same (collectively, the "Marks") (which, together with the Works, shall be collectively referred to hereinafter as the "Intellectual Property"); and

WHEREAS, Assignor is the owner of the registered domain name FUTUREOFCHILDREN.ORG (the "Domain Name"); and

WHEREAS, Assignor has compiled an e-mail subscriber list, hardcopy subscriber list, and other hardcopy mailing lists (collectively the "Lists") for *The Future of Children* journal set forth on Schedule B (the "Lists"); and

WHEREAS, for the purpose of becoming the new publisher and owner of *The Future of Children* journal, Assignee is desirous of (i) acquiring all of Assignor's right, title and interest in and to the Intellectual Property and the Domain Name and the Lists

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which Assignor and Assignee hereby acknowledge:

1. Assignor warrants that it has the lawful right to assign, transfer, convey, and/or license all of the rights as described hereunder and that it is unaware of any current or potential litigations relating to the Works, Marks, Intellectual Property, or Domain Name.
2. Assignor hereby assigns, transfers and conveys to Assignee all of its right, title and interest in and to the Intellectual Property, including any registrations or pending applications therefor, any and all copyright rights therein, any renewal rights thereto or extensions thereof, the goodwill of the businesses symbolized thereby, and all proceeds thereof,

including, without limitation, proceeds from any and all causes of action for infringement thereof and any and all royalties for any licenses thereof, and all rights to sue, bring actions for, recover and hold damages, profits and other compensation for any and all past and future infringements and unauthorized uses thereof, such Intellectual Property and associated rights to be held and enjoyed by Assignee, for its own use, and for the use of its successors, assigns or other legal representatives to the full end of the term or terms for which the Intellectual Property may be granted, as fully and entirely as the same would have been enjoyed by the Assignor, had the assignment contained herein not been made.

3. Assignor hereby assigns, transfers and conveys to Assignee all of Assignor's right, title and interest in and to the Domain Name, all registrations relating to the Domain Name, any trademark and/or the service mark rights in the Domain Name together with all goodwill connected with and symbolized by the Domain Name and any other intellectual property, proprietary rights and/or contractual rights relating thereto. Assignor shall authorize and instruct **Network Solutions**, the entity with which Assignor registered the Domain Name, to transfer the Domain Name to Assignee or Assignee's designee.

4. Assignor hereby assigns, transfers, and conveys to Assignee all of its rights, title, and interest in and to the Lists, including the right to make any changes in the "Lists," and utilize them for purposes solely in connection with the Future of Children journal and its works, including for the purposes of updating information or correcting errors.

5. Assignor agrees to furnish and execute such additional documents within fifteen (15) days of the Effective Date as Assignee or **Network Solutions** may require to effectuate and establish Assignee's ownership of the Domain Name, including completion of the register-provided name change agreement. Assignor further covenants and agrees that, upon the request of Assignee, and at Assignor's expense, Assignor shall execute all papers, make all rightful oaths, testify on behalf of Assignee, furnish such documents, materials, information and/or assistance, and do all other lawful acts necessary to perfect the assignment of the Intellectual Property to Assignee and otherwise carry out the intent of this Agreement.

6. In its own name and at its own expense, Assignee may register and enforce its rights in the Intellectual Property and Domain Name, and Assignor further promises and agrees that it shall, at the request of Assignee or its counsel and at Assignee's expense, execute, acknowledge and deliver all such further acts, deeds, assignments, transfers, powers of attorney and assurances as may be required to carry out the intent of this Agreement, and to transfer and vest title to and in the Intellectual Property, Domain Name, and associated rights set forth in this Agreement and to procure, maintain, enforce and protect the right, title and interest in and enjoyment of all of the Intellectual Property, Domain Name, and associated rights assigned, transferred and conveyed to Assignee pursuant to this Agreement; provided, however, this Agreement shall be effective regardless of whether any such additional documents are executed.

7. This Agreement shall be binding upon Assignor, Assignor's successors and assigns, and upon all others acting by, through, with or under Assignor's direction or control, and all those in privity therewith.
