This assignment is effective as of October \_\_\_\_, 2006.



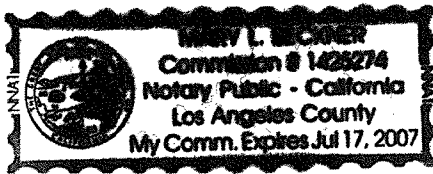
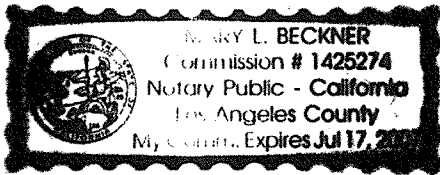
