## Release of Lien on Trademarks

**Release of Lien on Trademarks**, dated as of February 12, 2007 (the "*Release*"), by Bank of America, N.A. ("*Bank of America*"), as administrative agent under the Credit Agreement referred to below for the Secured Parties (as defined in the Security Agreement referred to below) (in such capacity, the "*Administrative Agent*"), in favor of Foamex L.P. ("*Foamex*") and each of the other entities listed on the signature pages hereof (each a "*Grantor*" and collectively with Foamex, the "*Grantors*").

### WITNESSETH:

WHEREAS, pursuant to the Credit Agreement, dated as of August 18, 2003, (as amended, amended and restated, supplemented or otherwise modified from time to time, the "*Credit Agreement*") entered into among the Grantors, the financial institutions from time to time party thereto as lenders (the "*Lenders*"), the Administrative Agent, Banc of America Securities LLC and GECC Capital Markets Group, Inc., as co-lead arrangers, Banc of America Securities LLC, as sole book manager, General Electric Capital Corporation, as syndication agent and Congress Financial Corporation (Central) and Bank One, N.A., as co-documentation agents, the Lenders have severally agreed to make extensions of credit to Borrowers (as defined in the Credit Agreement) upon the terms and subject to the conditions set forth therein;


WHEREAS, in connection with a Pledge and Security Agreement dated as of August 18, 2003, (as amended, amended and restated, supplemented or otherwise modified from time to time, the "*Security Agreement*") in favor of the Administrative Agent, the Grantors executed and delivered a Trademark Security Agreement dated as of August 18, 2003 (the "*Trademark Security Agreement*") pursuant to which all the Grantors granted to the Administrative Agent a security interest in and lien on all right, title and interest of the Grantors in certain Trademark Collateral (as defined in the Trademark Security Agreement) and as set forth on Schedule I attached hereto (the "*Released Trademarks*") to secure the performance of certain obligations (the "*Obligations*"); and

WHEREAS, the Obligations have now been satisfied, the Grantors have requested that the Administrative Agent release, without representation or warranty of any kind, any and all interest it may have in the Released Trademarks, and the Administrative Agent has agreed to do so.

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt of which is hereby acknowledged, the Administrative Agent does hereby release, relinquish and discharge, without representation or warranty of any kind, its security interest in, to and under the Released Trademarks.

IN WITNESS WHEREOF, the Administrative Agent has caused this Release to be duly executed and delivered by its officer thereunto duly authorized as of the date hereinabove set forth.
