ASSIGNMENT OF MARK


WHEREAS, Healthtech Products, Inc., a Missouri corporation with offices at 1644 Lotsie Boulevard, St. Louis, Missouri ("Assignor"), is the owner of all right, title and interest in and to the mark THE BATHER (the "Mark"), including but not limited to U.S. Trademark Registration No. 1,273,178 (the "178 Registration") in International Class 010 for "contoured bathing apparatus designed especially for invalid use, consisting primarily of tub, shower, whirlpool and sitzbath"; and

NOW THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, and intending to be legally bound, Assignor hereby sells, assigns and transfers to Assignee, *effective January 1, 2007*, all right, title and interest in and to (i) the Mark, (ii) the '178 Registration, (iii) all income, royalties, damages and payments now or hereafter due or payable with respect to the Mark, (iv) all rights of action arising from the Mark, including all claims for damages by reason of past, present and future infringement of the Mark and the right to sue and collect damages for such infringement, to be held and enjoyed by Assignee for its own use and benefit and for its successors and assigns as the same would have been held by Assignor had this assignment not been made, and (v) the goodwill of the business symbolized by the Mark.
