**ARTICLES OF AMENDMENT  
TO THE  
ARTICLES OF INCORPORATION  
OF  
WILINK U.S. HOLDINGS INC.  
(changing its name to PrecisionIR Group Holdings Inc.)**

Pursuant to Section 13.1-710 of the Code of Virginia of 1950, as amended, these Articles of Amendment provide as follows:

1. Name. The name of the corporation is WILink U.S. Holdings Inc., a Virginia corporation (the "Corporation").

2. Amendment. Article I of the Articles of Incorporation of the Corporation is hereby amended by deleting it in its entirety, and inserting in its place the following:


Article I. Name. The name of the Corporation is  
PrecisionIR Group Holdings Inc. (the  
"Corporation").

3. Action by Board of Directors and Sole Shareholder. By joint written consent of the Board of Directors and the Sole Shareholder of the Corporation, dated January 1<sup>st</sup>, 2007, all the Directors and the Sole Shareholder approved and adopted the foregoing amendment to the Articles of Incorporation of the Corporation. Such action was in accordance with the applicable provisions of the Virginia Stock Corporation Act.

4. Effective Time and Date. The Certificate of Amendment issued with respect to those Articles shall be effective upon issuance by the Virginia State Corporation Commission.

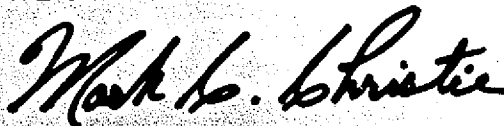
