THIS ASSIGNMENT OF TRADEMARK ("Assignment") is made as of the 12th day of April, 2007 between **HONEY BAKED HAM, INC.**, a California corporation ("Assignor"), and **HBH LIMITED PARTNERSHIP**, a Michigan limited partnership ("Assignee").

WHEREAS, Assignor has adopted and used the trademark "DEEP GLAZED" (the "Mark") in connection with its business, and has applied for registration of the Mark on the Principal Register of the United States Patent and Trademark Office (Application Serial Number 77/098042); and

WHEREAS, Assignee wishes to acquire all of Assignor's rights in and to the Mark, and Assignor has agreed to assign such rights to Assignee;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. **Assignment**. Assignor hereby assigns, transfers and conveys to Assignee any and all right, title and interest in and to the Mark, including any and all pending applications and registrations, together with the goodwill of the business symbolized by the Mark, and the right to recover damages and profits and all other remedies for past infringements related to the Mark.

2. **Consideration**. Simultaneous with execution of this Assignment, Assignee shall pay to Assignor the sum


