**FIRST:** The name of each constituent corporation is **PATENT RESOURCES INSTITUTE, INC.**, a Delaware corporation, and **PRG LANDON, INC.**, a Virginia corporation.

**SECOND:** The Agreement of Merger has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations pursuant to Title 8 Section 252 of the General Corporation Law of the State of Delaware.

**THIRD:** The name of the surviving corporation is **PRG LANDON, INC.**, a Virginia corporation.

The Secretary of State shall mail any such process to the surviving corporation at 1700 Diagonal Road, Suite 450, Alexandria, Virginia 22314.


