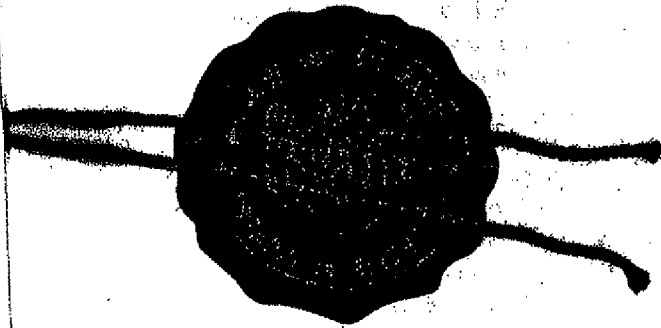

AMENDMENT TO THE ARTICLES OF ASSOCIATION

This second day of January two thousand and six, appeared before me, KRISHNA VAN ZUNDERT, hereinafter also referred to as "civil-law notary", deputy of MAARTEN WILLEM VAN DER ZANDEN, a civil-law notary practising in Eindhoven:

Mrs HENDRIKA FRANCINA JOHANNA MARIA VAN DEN HEUVEL-LAMMERS, born in Budel on the thirtieth of July nineteen hundred and sixty, employed and for the purpose of this document choosing domicile at my civil-law notary's office (5613 AM Eindhoven, Prof. Dr. Dorgelolaan 14).

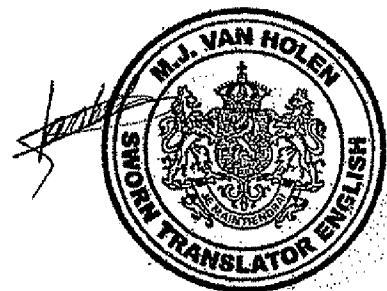
The person appearing established the following facts:

- a) The public limited company INTERBREW NEDERLAND N.V. has its registered office in Breda and its actual place of business in 4811 CA Breda, Ceresstraat 1. The company was incorporated on the twenty-ninth day of April nineteen hundred and thirty.

The articles of association were most recently amended by a deed executed on the eleventh day of November two thousand and five (11-11-2005) before M.W. van der Zanden, civil-law notary in Eindhoven, in respect of which the ministerial certificate of no objection was issued by a decision dated ten November two thousand and five (10-11-2005), number N.V. 42764.

The company is listed in the trade register of the Chamber of Commerce and Industry for West-Brabant under file number 20080399.

- b) In the extraordinary general meeting of shareholders held on six December two thousand and five, it was decided unanimously to partially amend the articles of association. The proceedings of that meeting appear from a record of the meeting drawn up by the above M.W. van der Zanden.
- c) The above meeting has authorised the person appearing to apply for the ministerial certificate of no objection, to make such changes to the draft of the deed of amendment to the articles of association as should be required by the government





in order to obtain that certificate, as well as to have the deed concerned executed and to sign it.

- d) In respect of the present amendment to the articles of association, the ministerial certificate of no objection as referred to in the law has been issued by a decision of thirteen December two thousand and five, number N.V.42764, which will be attached to this deed.

Based on the above, the person appearing hereby stated to partially amend the company's articles of association as follows:

Article 1 paragraph 1 will read as follows:

1. The company bears the name InBev Nederland N.V.

The person appearing is known to me, civil-law notary.

This deed was executed in Eindhoven on the date stated in the preamble of this deed.

I, civil-law notary stated and explained the substance of this deed to the person appearing. The person appearing declared not to appreciate a full reading of this deed and to have taken note of the contents of this deed and to agree to it. Following a limited reading, this deed was subsequently signed by the person appearing and by me, civil-law notary.
