
NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby accepted and acknowledged, the parties agree as follows:

2. Jones Pharma further agrees to take all further actions, and to execute any and all further documents and instruments as may be necessary or desirable to confirm this assignment.



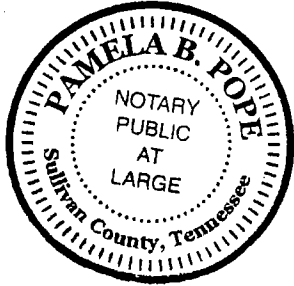
