**ASSIGNMENT OF INTEREST
IN TRADE MARKS**

WHEREAS, BPT IP, LLC (“BPT”), a Delaware limited liability company located at 14th Floor, 2 Bethesda Metro Center, Bethesda, MD 20814, acquired the trade marks identified on the attached Schedule A (the “Marks”) from Bridgeport Machines, Inc. (“Bridgeport”), a Delaware corporation; and

WHEREAS, the Marks were subject to an exclusive license agreement, dated September 13, 1999, from Bridgeport to EZ-Cam Solutions, Inc. (“EZ-Cam”), a Pennsylvania corporation formerly known as PCAM Solutions, Inc. located at 235 E. 83rd Street, Suite 7H, New York, NY 10028, which agreement included an obligation of assignment at the end of the license term;

WHEREAS, BPT assigned the Marks to Hardinge, Inc. (“Assignor”), a New York corporation located at One Hardinge Drive, Elmira, NY 14902, by deed of assignment dated November 3, 2004 and recorded by the United States Patent and Trademark Office on May 5, 2006; and

WHEREAS, EZ-Cam desires to acquire all rights in the Marks and, in order to induce Assignor to assign to EZ-CAM any remaining interest that BPT may have in the Marks, EZ-Cam is willing to waive any and all claims that it may have against Bridgeport, BPT or Assignor arising from (i) the prior assignment of the Marks to BPT and to Assignor, (ii) any prior use of the Marks by Bridgeport, BPT, or Assignor and (iii) any lapse of registrations of the Marks (collectively, the “Claims”).

NOW THEREFORE, in consideration of EZ-Cam’s waiver of any and all Claims that it may have against Bridgeport, BPT and Assignor, Assignor does hereby assign to EZ-Cam any remaining right, title, and interest in and to the Marks that it may have, including the goodwill of the business associated with the Marks, and the right to sue for past and future infringement thereof.

This assignment is effective as of January 12, 2007.
