**AFFIDAVIT OF JOSEPH H. KENNEDY IN SUPPORT OF THE KENNEDY CENTER
FOR REAL ESTATE EDUCATION'S OWNERSHIP OF THE ASR AND ACCREDITED
SELLER REPRESENTATIVE MARKS**


1. I, Joseph H. Kennedy, am the CEO of The Kennedy Center for Real Estate Education, Inc.
2. I have personal knowledge of the facts set forth in this affidavit.
3. The Kennedy Center for Real Estate Education, Inc. is the owner of United States Trademark Registration Numbers 3,071,769 and 3,093,851 for the word mark ASR; United States Trademark Registration Number 3,088,326 and United States Trademark Application Number 78/294,005 for the ASR mark and logo; and United States Trademark Application Numbers 78/603,158 and 78/603,171 for the word mark ACCREDITED SELLER REPRESENTATIVE.
4. In September 2005, The Kennedy Center for Real Estate Education signed a "Stock Purchase Agreement" with Seller Agency Council. The Stock Purchase Agreement recently has been improperly recorded against the above-identified registrations and applications as if it were an assignment of rights (it isn't). Section 1.1 of the Stock Purchase Agreement provides that Seller Agency Council could obtain all rights, title and interest to certain intellectual property assets from Kennedy Center in exchange for

490,000 shares of Seller Agency Council's common stock. The Stock Purchase Agreement recited that such a sale would take place at a future closing. No rights were transferred as a result of the execution of the Stock Purchase Agreement itself. Rather, Section 1.2 of the Stock Purchase Agreement gave Seller Agency Council 30 days from execution of the agreement to effect such a closing, whereby the Seller Agency Council was to deliver the required stock certificates to Kennedy Center. Upon receiving the stock certificates, Kennedy Center was to deliver a Bill of Sale to Seller Agency Council transferring certain intellectual property assets. No such closing ever took place between the parties. Seller Agency Council has never delivered any stock to Kennedy Center and Kennedy Center has not sold or otherwise transferred any rights in the trademarks to Seller Agency.


5. Therefore, ownership of the above-identified registrations and applications was never transferred to Seller Agency Council and remains with The Kennedy Center for Real Estate Education, Inc.
