Articles of Amendment to the Articles of Incorporation of Bank of the West are hereby executed by the corporation pursuant to RCW 30.08.055 as follows:

1. The name of the corporation is: Bank of the West.
2. The amendment to the Articles of Incorporation is as follows:

ARTICLE I.

Name and Duration

The name of this corporation shall be **AmericanWest Bank**, and its existence shall be perpetual.

3. This amendment was adopted by the Board of Directors of the corporation on June 16, 1999.

4. The amendment was approved by the sole shareholder of the corporation, namely United Security Bancorporation of Spokane, Washington, by resolution adopted on July 27, 1999, pursuant to RCW 30.08.090.
