RELEASE OF SECURITY INTEREST IN THE U.S. TRADEMARKS

WHEREAS, Fleet National Bank, with a business address of 208 Harristown Road, Glen Rock, New Jersey 07452, recorded a security interest by agreement dated the 12th day of February 2003, at Reel 2669, Frame 0308, on February 10, 2003, in the United States Patent and Trademark Office, in and to the trademarks listed on Exhibit A ("Marks"), owned by Mikron Infrared, Inc., with a principal business address of 16 Thornton Road, Oakland, New Jersey 07436 ("Debtor"); and

Now, therefore, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party does hereby release and discharge the security interest in the Marks, and does hereby assign unto the said Debtor all of its right, title and interest that may exist in and to the Marks, and in and to the registrations identified in Exhibit A herein, together with the goodwill of the business symbolized by the Marks.
