Release of Second Lien Trademark Security Agreement

This Release of Second Lien Trademark Security Agreement (the "Release"), dated as of May 14, 2007 is made by UBS AG, STAMFORD BRANCH, in its capacity as collateral agent pursuant to the Second Lien Credit Agreement, dated as of November 10, 2005 (in such capacity, the "Collateral Agent") in favor of QTC MANAGEMENT, INC. (the "Pledgor").

WHEREAS, in connection with the Second Lien Credit Agreement and a Second Lien Security Agreement, each dated as of November 10, 2005, Pledgor entered into a Second Lien Trademark Security Agreement dated as of November 10, 2005 and recorded in the United States Patent and Trademark Office as of December 7, 2005 at Reel 003205, Frame 0715 pursuant to which Pledgor granted to the Collateral Agent a security interest in and lien on all right, title and interest of Pledgor in certain trademarks, including the trademarks and trademark applications set forth on Schedule I attached hereto (the "Released Trademarks") to secure the performance of certain obligations (the "Obligations");

WHEREAS, the Obligations have now been satisfied, Pledgor has requested that the Collateral Agent release any and all interest it may have in the Released Trademarks pursuant to the Second Lien Security Agreement and Second Lien Trademark Security Agreement, and the Collateral Agent has agreed to do so.


