Pursuant to the provisions of T.C.A. § 48-29-104 of the Tennessee Limited Liability Company Act (the "Act"), the undersigned limited liability company adopts the following Articles of Amendment to its Articles of Organization:

1. The name of the limited liability company is MBK Entertainment, LLC.
2. The amendments, as adopted, are as follows:
  - a. The name of the limited liability company is changed from MBK Entertainment, LLC to Moll Anderson Home, LLC.
  - b. The street address and zip code of the principal executive office of the limited liability company is changed from 2600 Franklin Road, Nashville, Davidson County, Tennessee 37204 to 2303 21<sup>st</sup> Avenue South, Nashville, Davidson County, Tennessee 37212.
3. The amendments were duly adopted on February 23, 2006 by the written consent of the members.
