## ASSIGNMENT

### WHEREAS:


- A. The Assignor is the owner of the marks set out in the Schedule and the applications and registrations therefor ("the Trade Mark").



The Assignor as legal and beneficial owner does hereby sell, assign, transfer and set over to the Assignee all right, property, title and interest in and to the Trade Mark together with any right to sue for past infringement thereof and together with the goodwill of the business concerned in the goods and services in respect of which the Trade Mark is registered, to have and to hold absolutely and the Assignor covenants with the Assignee that it will do all such acts and things as may be necessary and convenient to procure the registration of the said Assignee as registered proprietor of the Trade Mark.
2. The Assignor hereby warrants that it is not aware of any claim which may affect the Trade Mark nor has it charged or encumbered the Trade Mark and the Assignee shall have and enjoy quiet possession of the Trade Mark uninterrupted by the Assignor or any person claiming under or in trust for the Assignor.


