We, Byron Cohen, President, and Leonard Bettinger, Assistant Secretary of BCCG, Inc., a corporation organized and existing under the laws of the State of Kansas, and with its registered office at 515 South Kansas, Topeka, Shawnee County, Kansas, do hereby certify that at the special meeting of the Board of Directors of said corporation held on the 9th day of March, 1992, said board adopted a resolution setting forth the following amendment to the Articles of Incorporation and declared its advisability, to wit:

Article One shall hence forth read in its entirety:

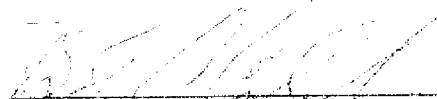
"The name of the corporation shall be: Celebrity China Company."

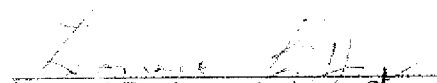

That at said meeting the stockholders entitled to vote did vote upon said amendment, and the majority of voting stockholders of the corporation had voted for the

proposed amendment certifying that the votes were 20,000 Common shares in favor of the proposed amendment and - 0- shares against the amendment.

IN WITNESS WHEREOF we have hereunto set out hands and affixed the seal of said corporation this 9th day of March, 1992.

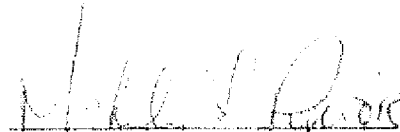
