

SUMMARY JUDGMENT

On the 21 day of November, 2006 came before this Court Plaintiff's Motion For Summary Judgment ("Motion") in the above-entitled and numbered cause. Appearing on behalf of Plaintiff, Otey Interests, L.P. d/b/a Worldwide Express was William L. Siegel of Cowles & Thompson, P.C. Defendant, C I Host, Inc. did not appear and respond. After reviewing the Motion and other pleadings on file, this court is of the opinion and finds that: (1) it has jurisdiction over this proceeding; (2) Defendant has been duly noticed of the hearing of the Motion; (3) there is no genuine issue as to any material fact regarding each and every element of Plaintiff's cause of action against Defendant; and (4) Plaintiff is therefore entitled to a judgment as a matter of law; it is therefore

ORDERED, that Plaintiff, Otey Interests, L.P. d/b/a Worldwide Express have and recover actual damages from Defendant, C I Host, Inc., the sum of \$15,063.59; it is further,

ORDERED, that Plaintiff, Otey Interests, L.P. d/b/a Worldwide Express have and recover reasonable attorneys' fees from Defendant, C I Host, Inc. the sum of \$6,500.00; \$7,500.00 in the event an application for writ of error to the Texas Supreme Court is filed, plus an additional \$7,500.00 if said application for writ of error to the Texas Supreme Court is granted; it is further,

ORDERED, that Plaintiff, Otey Interests, L.P. d/b/a Worldwide Express have and recover reasonable costs in sum of \$465.80 from Defendant, C I Host, Inc.; it is further,

ORDERED, that Plaintiff, Otey Interests, L.P. d/b/a Worldwide Express have and recover pre-judgment interest in sum of \$903.81 from Defendant, C I Host, Inc.; it is further,

ORDERED, that this award of attorneys' fees, pre-judgment interest and costs are part of the Judgment here rendered; it is further

ORDERED, that the Judgment here rendered shall bear interest at the rate of 8.25 percent per annum from the date this Judgment is entered, until paid.

All costs of court expended or incurred in this cause through the date of this Summary Judgment are adjudged against Defendant, C I Host, Inc. All writs and processes for the enforcement and collection of this Judgment or the costs of court may be issued as necessary. All other relief not expressly granted is denied.
