## TRADEMARK RELEASE AND REASSIGNMENT

This **TRADEMARK RELEASE AND REASSIGNMENT** is made as of May 18, 2007 by **GUARANTY BANK**("Guaranty").

### **W I T N E S S E T H:**

**WHEREAS**, Guaranty and UTEX Industries, Inc., a Texas corporation (the "**Grantor**"), were parties to that certain Trademark Security Agreement dated as of August 18, 2005 (the "**Agreement**"; capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Agreement), pursuant to which the Grantor granted a security interest to Guaranty in, among other things, the Trademark Collateral (as defined below); and

**WHEREAS**, the Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on August 29, 2005, at Reel 3149, Frame 0080; and

**WHEREAS**, the Grantor has requested that Guaranty release its security interest in the Trademark Collateral and reassign the same to Grantor.

**NOW THEREFORE**, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. **Definition.**

"**Trademark Collateral**" shall mean:

(a) each Trademark listed on **Schedule I** annexed hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark; and

(b) all products and proceeds of the forgoing, including without limitation, any claim by Grantor against third parties for past, present or future (a) infringement or dilution of any Trademark, or (b) injury to the goodwill associated with any Trademark.


2. **Release of Security Interest.** Guaranty hereby releases its security interest in and lien on the Trademark Collateral.

3. **Reassignment.** Guaranty hereby reassigns, grants and conveys to the Grantor, without any representation, recourse or undertaking by Guaranty, all of Guaranty's right, title and interest in and to the Trademark Collateral.
