This Assignment Of Trade Marks is made on 12th May 2006

Between

- (1) **BIOLAB INC**, a company incorporated under the laws of the state of Delaware, USA with federal identity number 22-2268754 and state of Delaware identity number 0867630 and having its registered office at c/o Corporation Service Company, 2711 Centerville Road, Suite 400, Wilmington, Delaware (USA) 19808;
 - (2) **GREAT LAKES CHEMICAL CORPORATION**, a company incorporated under the laws of the State of Delaware, USA with federal identity number 95-1765035 and state of Delaware identity number 0741228 and having its registered office at c/o Corporation Service Company, 2711 Centerville Road, Suite 400, Wilmington, Delaware (USA) 19808; and
 - (3) **GREAT LAKES CHEMICAL (EUROPE) GmbH**, a company incorporated under the laws of Switzerland, with registered number CH-440.4.002.948-2 and having its registered office at Bahnhofplatz 65, CH-8501 Frauenfeld (Switzerland) together the "Assignors"; and
- (2) **BWA Water Additives UK Limited** (No. 05657343) a company incorporated under the laws of England and Wales whose registered office is at 100 Barbirolli Square, Manchester, M2 3AB (**Assignee**).

Whereas

- (A) The Assignors are the owners of the trade marks and trade mark application details of which are set out in the Schedule (**Trade Marks**).
- (B) Pursuant to a sale and purchase agreement dated 12th May 2006, the Assignors have agreed that the Trade Marks should be assigned by the Assignors to the Assignee for the consideration and on the terms and subject to the conditions set out in this Assignment.

It is agreed as follows:

1 Assignment

- 1.1 For good and valuable consideration (the receipt and sufficiency of which is hereby acknowledged by the Assignors), the Assignors hereby assign to the Assignee absolutely, all of their right, title, interest and goodwill in and to the Trade Marks, together with the right to sue and retain any damages obtained in respect of every act of infringement of the Trade Marks occurring prior to the date of this Agreement.
- 1.2 If in any country the execution, after the date of this Assignment, of a confirmatory assignment of or other document concerning the Trade Marks in that country would be ineffective or invalid by reason of the transfer effected by this Assignment, then this Assignment shall be deemed to be an agreement to assign, and not an assignment of the Trade Marks in that country.

2 Further Assurance

- 2.1 In the event that the validity or ownership of any of the Trade Marks and/or any trade mark granted pursuant to any application included within the rights assigned by Clause 1 (**Applications**) is challenged on any point upon which the Assignors have advice or have or can procure information which may assist in meeting or defeating or reducing the effect of such challenge the Assignors agree and/or undertake to supply such advice and/or to supply or procure the supply of such information without unreasonable delay but subject to the right

to charge the Assignee reasonable out of pocket expenses incurred in pursuance of this provision.

- 2.2 The Assignors shall, and shall use reasonable commercial endeavours to procure that any third party shall, execute such further documents and do such further acts and things (including where necessary prosecuting any Applications in the name of the Assignors until grant) as the Assignee may reasonably request from time to time by way of further assurance of the rights assigned under this Assignment, subject to the right to charge the Assignee reasonable out of pocket expenses incurred in pursuance of this provision.
- 2.3 The Assignors shall use reasonable commercial endeavours to procure that the legal title to each of the Trade Marks currently registered in the name of a third party is transferred to the Assignee as soon as possible following execution of this Assignment. At the Assignors' cost, the Assignors shall, and shall use reasonable commercial endeavours to procure that any third party shall, execute such further documents and do such further acts and things as are necessary to procure that the legal titles to the Trade Marks currently registered in the name of a third party are vested absolutely in the Assignee.

3 General

- 3.1 This Agreement may be executed in one or more counterparts, and by the parties on separate counterparts, but shall not be effective until each party has executed at least one counterpart and each such counterpart shall constitute an original of this Agreement but all counterparts shall together constitute one and the same instrument.
- 3.2 Unless otherwise indicated, the parties shall bear their own costs in performing or otherwise discharging their respective obligations under this Agreement.
- 3.3 No person other than a party to this Agreement shall be entitled to enforce any term of it and the parties expressly agree that the Contracts (Rights of Third Parties) Act 1999 shall not apply to this Agreement.

4 Law

This Assignment shall be governed by and construed in accordance with English law and both parties hereby submit to the non-exclusive jurisdiction of the English Courts.

Executed as a deed by the parties or their duly authorised representatives on the date of this Deed.
