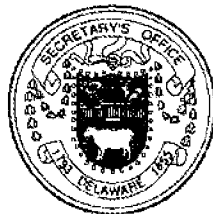

FIRST: That the board of directors of the Corporation duly adopted resolutions declaring advisable an amendment to the Certificate of Incorporation of the Corporation. The resolutions setting forth the proposed amendment are as follows:

RESOLVED, that Article I of the Certificate be amended by deleting the existing Article I and substituting the following in its place:
