## TRADEMARK ASSIGNMENT

This Trademark Assignment (the "Assignment") is effective as of the 1st day of April, 2007, (the "Effective Date"), by and between ZYVEX CORPORATION, a Texas corporation having its place of business in Richardson, Texas ("Assignor"), and ZYVEX PERFORMANCE MATERIALS, LLC, a Texas limited liability company having its place of business at 1321 N. NOW THEREFORE, in consideration of the mutual covenants of the parties, and other good and valuable consideration provided in the Merger Agreement, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby assigns and transfers *nunc pro tunc* to Assignee, its successors, assigns and legal representatives, all worldwide right, title and interest in and to the Trademarks together with all corresponding goodwill, as well as Assignor's right to sue for and obtain remedies against past, present and future infringements of any or all of the foregoing, and all rights of priority and protection of interests therein under the laws of any jurisdiction worldwide.

Assignor agrees to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers and to otherwise take such action as is necessary to perfect such rights, title and interest in Assignee, its successors, assigns and legal representatives.

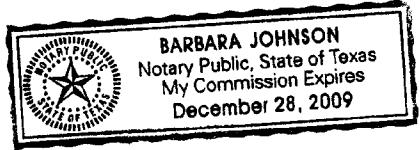

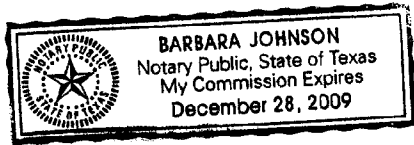
