ARTICLES OF MERGER

NUPETRA LLC,
a Delaware limited liability company and
NUSCI LABORATORIES LLC,
a Delaware limited liability company
with and into

Pursuant to the provisions of Section 347.725 of the Missouri Revised Statutes, the undersigned certify the following:

1. The names and jurisdictions of organization of each of the constituent entities which are to merge are:
 - (a) NuPetra LLC, a Delaware limited liability company
 - (b) NuSci Laboratories LLC, a Delaware limited liability company
 - (c) Applied Food Biotechnology, Inc., a Missouri corporation
2. NuPetra LLC, a Delaware limited liability company and NuSci Laboratories LLC, a Delaware limited liability company, shall each merge with and into Applied Food Biotechnology, Inc., a Missouri corporation, in accordance with the Agreement and Plan of Merger (such merger is referred to herein as the "Merger") and which Agreement and Plan of Merger has been authorized and approved by each of the constituent entities as required by Section 347.720 of the Missouri Revised Statutes.

4. The name of the surviving entity is Applied Food Biotechnology, Inc., a Missouri corporation (the "Surviving Entity").

6. There are no amendments or changes to the organizational documents of the Surviving Entity and the organizational documents of the Surviving Entity shall be its organizational documents.
7. The executed Agreement and Plan of Merger is on file at the principal place of business of the Surviving Entity, located at 3 Research Park Drive, St Charles, Missouri 63304.
8. A copy of the Agreement and Plan of Merger will be furnished by the Surviving Entity, on request and without cost, to any partner, shareholder, member, or their equivalent of any entity that is a party to the Merger.






