**TRADEMARK ASSIGNMENT AGREEMENT**

WHEREAS, by resolution of the board of directors of Portal Publications, Ltd a Delaware corporation ("*Portal*"), and with the consent of the shareholders of Portal, on April 5, 2007, Portal, in accordance with the assignment for benefit of creditor laws of the State of California, transferred ownership of all of its right, title and interest in and to all of its assets to PL (fbo), LLC, a California limited liability company ("*Assignor*"), and in so doing has also designated Assignor to act as the assignee for the benefit of creditors of Portal (the "*General Assignment*");

WHEREAS, Assignor and Assignee desire to memorialize the transfer of Assignor's trademarks and related rights to Assignee.

**NOW, THEREFORE, BE IT KNOWN**, pursuant to the Asset Purchase Agreement, Assignor has conveyed, assigned, transferred, delivered and set over to Assignee, its successors and assigns, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, all right, title and interest in and to any and all trademark rights throughout the world, including any and all applications, registrations, and common law marks, together with the goodwill of the business associated with and symbolized by same, held by Assignor immediately prior to the consummation of the General Assignment, including those set forth in **Schedule A** hereto, together with all common law rights therein. and the right to sue for past infringement of any and all of said trademarks.

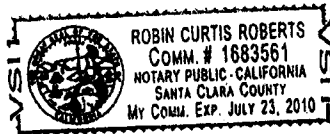
