RELEASE OF SECURITY INTEREST IN TRADEMARK

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS dated as of May 23, 2007 (this "Release") is made by and between The Toronto-Dominion Bank, (the "Secured Party") and KIK Holdco Company (the "Grantor").

WITNESSETH:

WHEREAS, Grantor granted the Canadian Imperial Bank of Commerce a security interest in certain of the Grantor's United States trademarks and trademark applications and, in particular, the trademarks set forth on Attachment I hereto pursuant a Security Agreement executed August 23, 2002 and recorded in the United States Patent and Trademark Office as of October 22, 2002, at Reel 2603, Frame 0355, and the trademarks set forth on Attachment II hereto pursuant to Security Agreement executed August 23, 2002 and recorded in the United States Patent and Trademark Office as of June 3, 2005, at Reel 3126, Frame 0675, (collectively the "Trademarks") which security interest was assumed by the Secured Party herein on May 17, 2005;

WHEREAS, pursuant to the Assignment and Assumption of Security Interest, dated May 17, 2005 and recorded in the United States Patent and Trademark Office as of June 28, 2005, at Reel 3144, Frame 0042, the Grantor granted to the Secured Party a security interest in the Trademarks;

WHEREAS, the Secured Party wishes to: (i) release all of its security interest covering the Trademarks; (ii) restore all right, title and interest in and to the Trademarks to Grantor; and (iii) to dissolve any and all liens and encumbrances respecting the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party does hereby release its security interest in the Trademarks, and discharges, quit claims and relinquishes unto the Grantor (in each case without recourse and without any representation or warranty) any and all rights, title and interest it has in and to the Trademark.
